Michael Sayles – Village Administrator

- Michael updated the Village Board on the Marina Dr./Birch Ln. sewer project. The contractors have entered the last phase of construction, building a new pump station at the corner of Marina and Harborview Dr. and then will proceed with the electrical work. Hopefully all will be completed by the end of the month, weather permitting. The initial worry of how wet the digging would be has surprised everyone as having been significantly dry.
- Michael informed the Village Board that the new playground for Main Street Park is on its way to Sylvan Beach, hopefully arriving next week. The Village DPW is busy prepping the site to get it ready for installation.
- Michael informed the Village Board that the fountain will be shrink wrapped this week for the winter.
- Michael handed out a "Parking Summary" to the Village Board members with the totals for the season.
- Michael reported there is a small surplus of rock (approx. 1 loader bucket full) at the Village DPW he would like to advertise on the Village Facebook page for residents to turn in sealed bids on if they would like to purchase them. The Board agreed and because of the small amount they agreed to have the clerks to accept the highest offer. Trustee Daily suggested Michael check with the Town of Vienna first to see if they may have a need for it.

Bill DeFazio – WWTP Operator

- Bill informed the Village Board that he has been assisting the contractors for the Marina Dr. / Birch Ln. sewer project with various tasks.
- Bill also informed the Village Board that Jack Dodson, Engineer for the WWTP Project Upgrade informed Bill there has been progress with the paperwork for the upgrade and the Village should be able to start moving forward on the project.

Patrick Goodenow - SVBRA

- Pat informed the Village Board he had a conversation with Bernie Clark of the Blues Society & Picnic which is held every summer. The society has voted to do a stand-alone event for this upcoming summer rather than a joined event with Pirates weekend as they did this past summer.
